

License aspects

Copyright law (Urheberrechtsgesetz, UrhG) also applies, without restriction, to electronic documents.

As an author, you enter into a publication contract with the University Library, which, among other things, specifies the possibilities for use of your publication.

Publishing agreements can also be drawn up for interrelated works such as continuations or series.

Authors grant a so-called „simple right of use“ so that their work can be made accessible on the Internet by the University Library. This means that authors can continue to publish their work elsewhere, both in print and digitally, e.g., in a publishing house. In the case of parallel publications, the publishing houses now often consent to the publication which has already taken place, or which will appear with a slight delay on a non-commercial publication server/ repository.

It is the responsibility of the authors or editors to ensure that the author's rights and exploitation rights of third parties are respected - this includes the rights to text and images

Research and full text access

All documents can be viewed and downloaded online in full text in and from the University Repository as well as searched for in local and national library catalogs and internet search engines.

Readers are allowed to make single reproductions or copies of a work for their own private and academic use (§ 53 UrhG).

Many authors additionally allow the production of print-on-demand copies - the ordering of individual printed copies from local copy stores.

What does the University Repository offer?

The University Repository of the University of Tübingen offers the possibility to publish scientific works from members of the university as open access documents, free of charge on the Internet.

It is also possible to present related works, e.g. publication series or congress reports in so-called „portals“, under a separate overview page in the Repository.

We meet international standards in the areas of author support, system security, metadata and long-term availability (Dublin Core, DINI, DDC).

Advantages of online publication

- Fast, free and uncomplicated publishing
- Low costs for dissertation publication, since only a few printed copies need to be handed in.
- Publications are available for free worldwide on the Internet
- Guaranteed archiving, document authenticity and citability
- The generated checksum (hash code) guarantees protection against falsification
- Records generated in library catalogs and search engines (Google, BASE, OCLC, etc.)
- Author support and training courses
- Uniform and permanent publication

Publish online

Electronic registration:

If you wish to publish a document, please choose the menu „Publish“ on our homepage and follow the instructions provided. In just a few steps you can transfer your document to the University Repository.

The transfer takes place after entering your details in the spaces provided on the password-protected web page.

To allow an effective search for the document each submission is indexed using the bibliographic metadata according to the Dublin Core scheme and contains an abstract, a classification and keywords. This data must be entered into the form by the author during submission

A dissertation must be uploaded in PDF/A format as well as in the original format (e.g. Word, Open Office, LaTeX). When publishing other documents, the document in PDF/A format is sufficient.

Requirements:

The author must be entitled to publish the document. The author holds the copyright to the document and has not made any disposition contrary to the terms granted in the publishing contract with the university („Veröffentlichungsvertrag“). The author also has the necessary rights to the text and images used in the document.

An „electronic document“ may contain text, graphics, audio and/or video sequences. It is available in digital form in PDF/A format and is intended for distribution to the public.

The document is provided and made available in its final version.

Necessary documents

For dissertations: (Please be sure to consult with the responsible Dean's Office beforehand!)

- Printing permission from the Dean's Office (with an additional approval from your supervisor for the Faculty of Science and Faculty of Medicine).
- Publishing contract („Veröffentlichungsvertrag“), two copies, signed by the author
- Declaration of consent („Übereinstimmungserklärung“), signed by the author
- Printed copies of the thesis (Number of copies differs according to the faculty.) The copies must be bound in adhesive binding. Ring or spiral binding is not permitted. The electronic version must exactly match the print version, including formatting and pagination.

Any other examination theses:

- Publishing contract („Veröffentlichungsvertrag“), two copies, signed by the author
- Declaration of consent („Übereinstimmungserklärung“), signed by the author
- An informal written recommendation from the supervisor that includes evidence of a grade of 1 or 2.
